Dissertation: "The Puzzling Nature of Material Objects: A Study of Material Coincidence"

Spatiotemporal coincidence is the idea that two or more numerically different objects can have the same set of parts, and thereby occupy the same space, simultaneously. I defend spatiotemporal coincidence from three common objections. I show how these objections rely on contentious physicalist intuitions. My analysis has implications for assessing criteria for material objects. Specifically, the objections against spatiotemporal coincidence depend on principles that represent criteria of plausibility for a theory of material objects. As I show, spatiotemporal coincidence can violate such principles without compromising theoretical plausibility, suggesting that the principles are unreliable. My analysis also indicates that spatiotemporal coincidence is at odds with a physicalist metaphysics of objects. I argue that without spatiotemporal coincidence, such a metaphysics is at best incomplete. We need material coincidence in order to preserve important intuitions concerning the persistence conditions of objects.
